#### **AFRICA**

As the Board of Church and Society assumes a more global focus, we believe significant resources ought to be directed to advocacy on behalf of the poor in Africa, where many of the world's poorest people live. Systemic injustice still prevents many Africans from reaching their potential, and many would benefit from programs to pull them out of poverty into self-sufficiency. Support

#### **BIBLICAL AUTHORITY**

Pet 60227 Page 189 Preamble to Social Principles Support This petition makes some additions to the Preamble to the Social Principles that reinforce the Bible as our "true rule and guide for faith and practice." It does so, however, in a winsome way, giving room for disagreements about biblical interpretation.

#### CHURCH AND SOCIETY BOARD STRUCTURE

Bringing the board's structure into a new focused and representative model will help the board more effectively address the needs and concerns of church and society.

Pet 60668 Page 197 **Reduce Board Size of GBCS** Oppose While this petition would reduce the board's size in keeping with other general agency boards, it would also eliminate any proportional representation on the board from larger jurisdictions and minimizes representation from the central conferences.

Pet 60961 Page 195 Permissiveness in AC Structure – GBCS Support This petition gives greater flexibility to annual conferences in how they structure their church and society responsibilities.

Pet 60577 Page 196 **GBCS** Priorities Support This petition makes the General Conference responsible for setting priorities for the board, rather than simply allowing the board to set its own priorities without the input of General Conference.

Pet 60728 **Responsibilities of GBCS** Support Page 196 This petition designates actual priorities for the board to pursue in its work.

# **CLIMATE CHANGE**

Pet 60702 Consider Page 189 Global Good Stewardship This petition removes mandatory governmental intervention in greenhouse gas emissions in favor of a call to voluntary cooperation, with a focus on clean water and malaria control as urgent needs in the Global South.

#### Pet 60710 Page 190 **Global Climate Stewardship**

This petition calls for divestment from all fossil fuels industries in an effort to reduce climate change. While well-intentioned in terms of helping combat climate change, the financial penalty could be severe, jeopardizing the church's fiduciary stewardship. It also stigmatizes a whole industry in which many of our members earn their livelihood. Would the proponents of this policy be willing to forego the tithes and offerings of these members, potentially hurt by our investment decisions? The policy also potentially hurts developing countries, which depend upon petroleum products for improving their economy and the lives of their people. This policy is a blunt instrument that would cause more harm than good.

# **CRIMINAL JUSTICE**

To End the "War on Drugs" Pet 60176 Page 267 Oppose This new resolution proposes that we end the "war on drugs" by "ending drug prohibition." The legalization of recreational use of addictive drugs would only open the door to more addiction. While sentencing reform is undoubtedly needed, and the emphasis should be on prevention and treatment of users, blanket drug legalization goes too far.

Pet 60463 Page 287 **Criminal Justice** AMEND or Oppose This new resolution combines several old ones into a comprehensive overview of restorative justice. It calls for the de-criminalization of drug use, prostitution, and consensual sexual activity (without clarifying that such activity must be between adults). We recommend amending the second paragraph on page 289 to delete these activities from the list to be decriminalized (or in the case of sexual activity, add the word "adult"). Prostitution, for example, is a primary driver of human trafficking and slavery and should continue to be criminalized.

# **HUMAN SEXUALITY**

Pet 60795 Justice and Law Page 194 Oppose We agree that it is appropriate for the church to speak out against violence targeting LGBTQ. persons. The insertion of LGBTQ concerns in this paragraph of the Social Principles seems out of place, as it would be the only particular issue addressed in a more generalized statement. These concerns about violence are already mentioned in ¶ 161F.

Pet 60895 Page 230 Military Service Regardless of Sexual Orientation Oppose This petition asks for the readoption of Resolution 5062, which calls for U.S. military service to be open to all persons, regardless of sexual orientation. Since that has been accomplished, the petition wants to amend the resolution to call for other countries to follow the same policy. We believe each nation needs to determine the feasibility of this step based on the culture and beliefs of that nation.

# ISLAM

Oppose Page 269 This new resolution has the laudable purpose of trying to lessen tensions and suspicion toward Muslims in the U.S. However, the petition romanticizes Islam, failing to take a realistic perspective. It also is too U.S.-centric and does not consider the perspectives of Africans and Filipinos, who live as neighbors with Muslim majorities in some areas who are persecuting Christians. Many of the commonalities the resolution draws between Muslims and Christians in the U.S. do not apply to other countries where United Methodists live. The resolution also undermines the urgency of presenting the Gospel to Muslims.

#### **ISRAEL AND PALESTINE**

The conflict between Israel and the Arab nations of the Middle East has got to be one of the most difficult and complex situations in world diplomacy over the past 25 years. As United Methodists, we believe strongly in Israel's right to exist as a Jewish nation, protected from the persecution and anti-Semitism that has followed them for over 2,000 years. Surrounded by hostile nations since 1948, Israel has a unique perspective on self-defense that those in more-secure nations perhaps cannot fully grasp.

On the other hand, United Methodists are particularly sympathetic toward Palestinian Christians, who have been suffering through a difficult time of not having an independent homeland, as well as oppression from Muslim majority populations. In addition, there is the imperative to move toward self-government and self-determination on the part of the Palestinian people, as well as in the surrounding Arab nations.

In the midst of this complex situation with loyalties on both sides of the conflict, the RRC would promote the following principles:

- In the complex Middle-Eastern conflict, there are faults on both sides that must be addressed. Our church serves the cause of a peaceful resolution of this conflict when we address the situation in a balanced way. Both sides in the conflict need to alter their policies and actions, and our church should maintain an even-handed approach.
- Our church ought to advocate for the renunciation of unjustifiable violence by both the Israeli and the Palestinian side.
- Our church ought to advocate for confidence-building measures on both sides, including ending the teaching of hatred for the other side in school curriculums, easing of security measures where possible, resumption of negotiations, refraining from new settlements, etc.
- While most people would agree with an eventual two-state solution to Israel/Palestine, it would be imprudent of our church to specify how that solution is to be reached. That is a matter for negotiation between the two sides. Therefore, we should not advocate actions that could prejudice the negotiation process one way or the other.
- Inasmuch as the church's expertise does not lie in diplomacy, we should be cautious about making sweeping statements about how the Middle-Eastern conflict should be resolved. We can promote the principles of peace, freedom, and security for both sides, without necessarily supporting a list of concrete policy proposals.

On the issue of divestment and boycotts, the RRC is opposed to this strategy. Economic exclusion of companies doing business in the West Bank often hurts Palestinian workers far more than it hurts Israeli companies. A recent boycott of Soda Stream forced them to move their factory out of the West Bank and cost hundreds of Palestinians their jobs. Applying economic pressure to Israel only makes them feel more vulnerable, making them less willing to compromise or make concessions. Such an approach is one-sided, in that these calls for divestment against companies doing business with Israel are not coupled with calling for additional steps to pressure the Palestinian side to stop its incitement to violence and teaching of hatred or to combat the pervasive corruption in Palestinian government. As long as Israel feels it is under attack, it will not change its policies.

#### PUERTO RICO

Pet 60971 Page 199 Release Puerto Rican Political Prisoner Oppose This petition calls for the release of Oscar Lopez Rivera from prison. Convicted and sentenced to a long prison term in the 1980's due to terroristic activities while pushing for Puerto Rican independence (a goal desired by only a minority of the Puerto Rican people), Rivera was unwilling to renounce the use of terrorism to achieve his political aims. All the others imprisoned with Rivera have been released on clemency, after they renounced terrorism. Rivera was a leader of the Puerto Rican terrorist group FALN that was responsible for murder, robbery, and other violent activities. Unless he is willing to renounce violence, we believe it would be inappropriate to release Rivera during this time when the world is suffering a new wave of violent terrorism. It would send a mixed message about our commitment to fight terrorism and provide for the safety and security of our people.

#### WAR AND PEACE

While there are a variety of views within the broader church and within United Methodism itself toward the use of war, The United Methodist Church has never been a pacifist denomination. While viewing war as an extreme last resort, most United Methodists would allow for the use of war to defend one's country and freedoms.

- Pet 60847 Page 296 Justice, War, and Defending the Innocent Support This new resolution defines and explains the Just War tradition and applies it to our understanding of war today in terms of defending the defenseless and limiting the excesses of armed conflict on both a personal and national level.
- Pet 60703 Page 194 War and Peace Support This petition removes a one-side pacifist view of war and replaces it with a more nuanced understanding of war as a last resort.
- Pet 60345 Page 229 Prayer and Support for Members of the Armed Forces Support This petition amends and readopts Resolution 5061, which calls for prayerful support for members of armed services and veterans, who have made great sacrifices to protect their country and bring peace.

#### ABORTION

Abortion is a controversial subject within both our church and society. As Christians, we should lean toward protecting and preserving life whenever possible. Scripture lifts up the personhood of the unborn (e.g., Jeremiah 1:5; Luke 1:44). The early church consistently spoke against abortion and infanticide, which was a common practice among the Romans. Increasingly early pre-term deliveries and pre-natal surgeries are demonstrating that the developing child is a separate life from the mother and in need of care and advocacy. While acknowledging that there are difficult and exceptional cases to consider, we believe United Methodism does best when it advocates on behalf of the lives of unborn children and supports the lives of women in crisis pregnancies.

These petitions contain proposed language changes to ¶ 161J in the Social Principles that would more specifically define the circumstances under which abortion might be morally justified. The most important change would add the word "physical" in the phrase "conflicts of life with life" to clarify that the circumstance envisioned is a life-threatening one, not a lifestyle decision. Amendments include advocating that, "whenever the unborn child may be capable of surviving outside his or her mother's womb, every reasonable effort should be made to preserve both lives." With the increasing advancement of medical technology, babies are viable outside the womb at an earlier point in the pregnancy. This means that late-term abortions have the potential of delivering a viable baby. Such children's lives should be preserved whenever possible. Amendments also commit the church to diminishing the high abortion rates and ground sexuality education in Christian teaching. Other amendments call for replacing the mother's "well-being" with "physical health." Such a broad term as "well-being" could cover any reason to justify abortion, from economic concerns to problems with family or the father to simple convenience. The taking of a life ought to be justified by more severe circumstances. Other amendments advocate for laws in civil society protecting the right of health care professionals not to participate in abortion. Persons who entered the health care field to save lives should not be compelled to take them. The committee should take all of the proposed amendments it can accept and combine them into one petition for approval.

The resolution on "Responsible Parenthood" has been used to justify continued advocacy in favor of abortion. The resolution rejects the belief that life begins at conception, allows for abortion when the pregnancy poses serious problems concerning the health or mental capability of the mother or child, advocates for legalized abortion with the only restriction being preventing gender selection abortions, believes that women have "a right to control their own bodies" (which includes the right to abort their unborn child) despite the evidence that the child is not part of the woman's body, but is a separate life growing within her, opposes parental consent requirements for minors obtaining abortions, classifies abortion as a "reproductive health service" (which euphemistically characterizes the ending of a pregnancy as reproductive health), and calls upon United Methodist-related health care institutions to offer "a full range of programs ... for reproductive health services" (including by implication, abortion). These positions are contrary to the more binding statement found in the Social Principles ¶ 161J, which offers only reluctant approval of abortion and lists a number of circumstances in which we oppose abortion. Either this resolution should be deleted entirely (by approving Petition 60748) or statements on abortion should be edited out of the resolution. There is enough good material on true family planning that the resolution would be helpful without any mention of abortion. We state in the Social Principles that abortion is not an acceptable means of birth control, so abortion ought not to be included in a resolution on family planning. Alternatively, the non-bolded petitions above offer some suggested amendments to the older version of Resolution 2025 that could be adopted. However, those amendments do not cover all the problematic passages in the newly revised version of Petition 60249.

#### Pet 60755 Page 332 Readopt Resolution

#### Support

This petition readopts an important resolution raising concerns about the deliberate targeting of unborn baby girls for abortion, which is a widespread problem in much of the world.

#### Pet 60837 Page 325 Withdraw from Religious Coalition for Reproductive Choice Support

This petition mandates withdrawal from RCRC, which is a pro-abortion lobbying coalition. It supports legal abortion and opposes all restrictions upon it. This is contrary to our United Methodist position on abortion, since we explicitly affirm the value of unborn life, oppose partial birth abortion, gender selection or eugenics abortion, and we favor parental notification and consent for abortion in young girls (which RCRC opposes). RCRC's "Prayerfully Pro-Choice: Resources for Worship" even promotes the use of religious rituals to bless abortion clinics for doing "God's work" and "holy work." RCRC's positions are so different from United Methodist positions that we should not be part of this coalition. Our involvement with RCRC has not influenced them to moderate their position. It has only allowed them to attach our United Methodist name to their secular policy agenda.

#### Pet 60838 Page 356 Deletion

#### Support

This petition deletes Resolution 3204, Support for the Religious Coalition for Reproductive Choice. It essentially gives unqualified support to RCRC. We should not support a coalition that

has views so different from our United Methodist understanding (see above under Petition 60837).

- Pet 60681 Page 317 Ministry to Those Who Have Experienced Abortion Support This petition advocates for the church to continue ministry to all women in crisis pregnancy situations, including those who terminate a pregnancy. The church should offer compassionate, non-judgmental ministry to all.
- Pet 60707 Page 322 Children as God's Gift Support This petition reminds us that children are a gift and blessing from God. It expresses concern about the declining birthrates in some countries that burden aging populations and may even lead to depopulation of some areas.
- Pet 60252 Page 359 UM Response to US Hospital Mergers Oppose This petition expresses concern about the merger of hospitals in the U.S. that could be depriving persons of access to emergency contraception and abortion services. We believe the concern over abortion access should be left out of this resolution. Hospitals are not needed for contraceptive services, and we should not be lobbying for greater access to abortion.

#### ADOPTION

#### Pet 60885 Page 317 Adoption

Adoption can provide a safe and healthy environment for children lacking parents or family to care for them. While acknowledging that adoption by non-traditional families can sometimes be superior to a foster family situation, we believe that it is preferable to place children in healthy heterosexual families. Children flourish best when they have parents of both genders. Same-sex adoptive couples by definition deprive children of a parent of one gender. The children are thus lacking in modeling and experience in relating to the parent of one gender.

#### **EUTHANASIA AND SUICIDE**

#### Pet 60690 Page 325 End of Life Options This petition calls upon the UM Church to support the "Death with Dignity Movement." This

movement favors the ability of persons to end their own lives, often with the assistance of a doctor. Suicide is not the answer to end-of-life suffering. We do not have the right to actively end our own lives—a role that belongs only to God. The introduction of assisted suicide opens the door to all kinds of abuse, as the nation of Belgium is learning, where many elderly persons are having their lives ended without their informed consent or without adequate safeguards. This petition runs counter to existing statements in our Resolutions opposing suicide.

#### Pet 60848 Page 396 Assisted Suicide and Euthanasia

This new resolution effectively lays out a life-affirming Christian approach to end-of-life issues. It stresses the "sacredness and importance of all life ... including for the very sick, the terminally ill, the depressed and despairing, the disabled and mentally impaired." We need to advocate on behalf of life, not open the door to more intentional death in society.

Pet 60470 Page 356 Faithful Care for Persons Suffering and Dying Support This petition rewrites an existing resolution with a focus on providing the best physical and spiritual care for persons who are suffering and dying. This nuanced and balanced resolution can provide effective guidance and advocacy for the provision of effective care.

Pet 60454 Page 388 Suicide: A Pastoral Response Support This petition is a comprehensive resolution on suicide and the church's ministry. It is balanced and biblically grounded, with compassion and care for all persons.

Pet 60794 Page 317 Suicide Oppose This addition to the Social Principles singles out suicide among LGBT youth, rather than focusing on all youth suicide. There are many risk factors accounting for youth suicide, and we should not focus on just one of them. We would accept this petition if the second half of the first sentence were removed.

#### GENDER

#### Pet 60793 Page 302 Gender

This petition is a cautious and compassionate response to gender confusion in our society. It advocates loving and godly counsel that emphasizes the sacredness of the human body.

#### **HUMAN SEXUALITY**

The church's balanced, compassionate, and biblically faithful position on the practice of homosexuality has been reaffirmed by ten General Conferences over 40 years. Despite vociferous disagreement by some parts of the church, it still represents the majority opinion of the grass roots church membership worldwide. Changing the church's position to allow same-sex weddings and/or the ordination of selfavowed practicing homosexuals would separate our church from 2,000 years of the church's consensus teaching and from 95 percent of world Christians today. It would also provoke separation of The United Methodist Church, forcing those who could not in good conscience live with the progressive position to leave the church. It is important to maintain clear lines of accountability to what our church has taught for 44 years and continues to require today. We oppose any efforts to remove or weaken our church's standards. Instead, we support efforts to strengthen accountability to our church's standards.

Oppose This petition adds "sexual orientation" as a "gift from God," implying that God creates people with various sexual orientations. This claim is not proven by science and is contrary to our scriptural understanding.

These three petitions all attempt to rewrite ¶ 161F in a more balanced and general way. Petition 60835 leaves out all mention of homosexuality, while affirming sexual relations only within monogamous marriage between one man and one woman. Petition 60944 is more explicit in giving persons rights based on sexual orientation, gender identity, and gender expression, but leaves out all mention of the church's stance on homosexuality and does not affirm that sexual relations are only within marriage. Petition 60836 is the same as 60835, with an added sentence enumerating the sexual expressions that are contrary to God's design (sex before marriage, adultery, polygamy, and same-sex relations). We thus prefer 60836, if the decision is made to rewrite ¶ 161F. Otherwise, we encourage keeping the language as it is now. It seems that it would weaken our stance on sexuality to rewrite the paragraph and not mention the most controversial aspect of sexuality that we are dealing with.

This petition adds some crucial theological understandings to the basis for our position on sexuality and its place within marriage.

#### Pet 60884 Page 313 Sexual Harassment

This petition adds to the categories under which we oppose discrimination – "gender identity" and "sexual orientation." While we oppose sexual harassment, we also oppose using the categories added. Including "gender identity" as a category is an implicit affirmation that a person's gender is based on one's own feelings, rather than biological reality, and that gender can be changed (all of which we do not accept). Opening the door on discrimination related to sexual orientation creates legislative enactments that contradict our stance that same-sex relations are contrary to God's will.

#### Pet 60778 Page 322 Equal Rights Pet 60887 Page 322 Right to Marry

These petitions endorse same-sex marriage and civil unions, contradicting our position against these in other places in the *Discipline*. Even when the laws or values of the societies surrounding our churches differ from our church's values, our church should not spread any confusion about how it understands marriage.

# Pet 60892 Page 327 Adoption in a Global Context

This amendment to an existing resolution adds support for policies enabling single persons, unmarried cohabiting persons, and same-sex couples to adopt children on an equal basis with heterosexual married parents. While acknowledging that adoption by persons in non-traditional families can sometimes be superior to a foster family situation, we believe that it is preferable to place children in healthy heterosexual families. Children flourish best when they have parents of both genders. Single adoptive persons and same-sex adoptive couples by definition deprive children of a parent of one gender. The children are thus lacking in modeling and experience in relating to the parent of one gender. Unmarried cohabiting couples often lack the long-term stability and safety of married heterosexual couples. We believe preference in adoption should be given to qualified monogamous heterosexual married couples.

Pet 60832 Page 308 Human Sexuality Support This petition opposes forced education in public schools that "normalizes sexual lifestyles that are in contrast to the traditional teachings of the Church." The petition calls for parental notification and consent prior to such instruction. Public school students should not be compelled to experience instruction that violates biblical moral values.

Pet 60451 Page 385 Global Health and Rights: Eradicating Sexual and Gender-Based Violence AMEND and Support This strong and comprehensive resolution addresses the problem of violence against girls and women, with many specifics and concrete recommendations. Amendments are needed to #8: add <u>"life-affirming"</u> reproductive health-care services; and #10: "Provide comprehensive sexuality education <u>consistent with Christian sexual ethics</u>."

Pet 60777 Page 321 Equal Rights Support This petition clarifies wording and includes strong condemnation against "violence, coercion, ridicule, stigmatization, or marginalization directed toward individuals who self-identify as either homosexual or former homosexual or as LGBT or ex-gay." It is important to include protections for persons who have left homosexual practice alongside those who continue in it. Both are subject to victimization.

Pet 60898 Page 398 Rights of All Persons Oppose This resolution exaggerates the level of religion-based persecution of LGBTQ persons. Its statements and recommendations are overly broad and would in effect indict The United Methodist Church's current opposition to same-sex marriage and the ordination of practicing homosexuals. It does not balance the need for ensuring civil rights with the need to ensure religious freedom. Finally, its triumphalist tone is out of place when addressing as sensitive and complex an issue as this.

Pet 60845 Page 395 Holiness and the Human Body Support This petition is a new resolution that outlines historic Methodist beliefs about the sanctity of the human body. This includes proper understanding of the role of sex, but the resolution goes beyond that to caring for the body and appreciating the impact that our lifestyle choices have on our bodies and on the lives of others. This positive statement is a good start toward a more comprehensive theology of the human body.

#### MARRIAGE

Marriage has always been the joining of a man and woman in a covenantal relationship. Christian marriage takes on the added significance of showcasing the image of God through complementary genders (Genesis 2) and symbolizing the union of Christ and the Church (Ephesians 5). In the face of attempts by secular society to reinvent or redefine marriage according to human whim, the church needs to stand fast on the eternal truth of God's word and its teaching on marriage. We oppose any attempt to redefine marriage, such as the four petitions below.

#### **ANNUAL CONFERENCE MEMBERSHIP**

Membership of annual conference includes retired clergy with voice and vote. We have reached the point when there are more retired clergy in most U.S. annual conferences than active clergy. Many of the retired clergy do not participate in annual conference, but they must be matched by an equalizing lay member of conference. This artificially inflates the number of people serving as members of annual conference, leading to extra expense for the meeting and an overrepresentation of laity. This also creates inequity with many of the central conferences, which have far fewer retired clergy, which then reduces their representation at General Conference.

# Pet 60603 Page 418 AC Membership of Retired Clergy Support

This petition creates more equity in balancing lay and clergy annual conference membership, as well as addressing the issue of General Conference representation.

Pet 60015 Page 417 Equalization of Annual Conference Membership Oppose While this petition addresses the lay/clergy imbalance of annual conference members, it does not address the issue of General Conference representation. If this approach is chosen, that element from Petition 60603 should be added here.

#### **DELEGATE NUMBER**

The Commission made the decision to reduce the number of delegates from nearly 1,000 to 850 for the 2016 General Conference and wants to further reduce the number of delegates for 2020. Such reductions heighten the inequity of representation between annual conferences and deprive annual conferences of the opportunity to create more diversity within their delegations. We believe the original intent of the *Discipline* was to allow the Commission to adapt the formula to bring the number of delegates just within the upper or lower limits set by the Constitution, not to allow the Commission to set an arbitrary number of delegates within the limits. If a lower number is to be chosen, then the General Conference should set that number, not the Commission. This petition writes that interpretation into the *Discipline*.

# Pet 60602 Page 435 Eliminate Conflict of Interest

This petition makes full-time paid staff of any general church agency ineligible for service as a General Conference delegate. Since the General Conference exercises oversight of the general agencies, it is a conflict of interest for agency employees to vote on their own agency's provisions. Staff members are still welcome to express their viewpoints in a variety of ways with General Conference delegates. We would be open to removing the prohibition on serving as a jurisdictional delegate.

Pet 60601 Page 403 Requirement for election Support This petition requires those standing for election as General Conference delegates to have read the entire Bible in order to be eligible for election. Since Scripture is our primary guide for faith and life, it is appropriate to require that those making decisions on behalf of the whole denomination should have read it.

Pet 60522 Page 436 Lay Delegate Residency Oppose This petition requires that all lay persons elected as delegates to General Conference must reside within the geographical boundaries of their annual conference. This proposal would unfairly exclude from serving lay persons who have legitimate reasons for living outside the conference. If someone has enough connection with the annual conference to be elected as a delegate, they have enough connection with the conference to represent it well, no matter where they live. This decision should be left up to the voters.

#### **EPISCOPAL ACCOUNTABILITY**

It is currently nearly impossible for bishops to be held accountable for maintaining their conduct within the requirements of the *Discipline*. No bishop has ever been brought up on charges through the committee on investigation since the church was founded in 1968, despite the filing of substantive complaints. One major reason is that a bishop's colleagues and friends are the ones tasked with holding the bishop accountable. The Council of Bishops sees itself as powerless to foster accountability. Regional differences in the church mean that different standards are used for bishops in different parts of the U.S. and the world. A variety of proposals have been submitted to rectify this situation and enable greater accountability. This petition is part of a comprehensive set of petitions. It envisions using the Interjurisdictional Committee on Episcopacy as the body to handle complaints against bishops, after expanding the IJCE to include members from the central conferences. It may be better to refer this petition to Committee 10, Judicial Administration, which is handling the bulk of these petitions, so that they can be acted on together.

#### **GLOBAL STRUCTURE**

These petitions are part of a comprehensive plan to restructure the church at the global level. The ultimate aim of this plan is to create the U.S. as its own central conference that is able to adapt the *Book of Discipline* to the unique needs of our cultural situation. In reality, it is an attempt to structure the church in a way that lessens the voices of African, European, and Filipino delegates in denominational affairs and would ultimately allow the U.S. part of the church to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. It is ironic that for many years the U.S. has had a determinative voice in how the central conferences operated, but now that the central conferences are able to have a strong voice in U.S. affairs, that voice is being rejected. The Renewal and Reform Coalition opposes this attempt to restructure the church in an effort to resolve our theological differences.

This petition would provide for a study process by a committee to examine how the U.S. delegates can deliberate on matters that pertain only to U.S. churches. While not opposed to the study *per se*, we believe that the underlying theological conflict needs to be resolved before any steps can be taken in this regard. Furthermore, the study committee does not fairly represent the U.S. jurisdictions. More importantly, this issue is one of the least pressing issues facing a church that is experiencing dramatic membership loss in the U.S. Other priorities should be the subject of our attention.

# MINIMUM REPRESENTATION

These petitions aim to correct the current imbalance between church membership and representation at General Conference. Under current rules, every annual conference, no matter how small, receives a minimum of two delegates at General Conference. This means that annual conferences of 500 members all the way up to 60,000 members receive the same representation. (Conferences over 60,000 add additional delegates according to the formula.) The present system encourages the proliferation of annual conferences in order to increase representation. Either of these two petitions might encourage consolidation of small conferences for better resourcing of ministry.

This petition would delay any change in the number of bishops in the U.S. It conflicts with a number of proposals being dealt with in Committee 12, Ministry and Higher Ed/Superintendency. It might be best if this petition were referred there, so that all proposals about the number of bishops could be handled by one committee. We believe that some changes to the formula for the number of bishops are needed to bring greater balance in terms of the number of members under the care of each bishop. Wide differences between small and large episcopal areas do not serve us well.

# **ORGANIC JURISDICTIONAL SOLUTION**

These petitions are part of a comprehensive plan to allow each jurisdiction to set its own standards for ministry, which would allow some jurisdictions to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. This plan would also allow local churches to affiliate with a different annual conference, annual conferences to affiliate with a different jurisdiction, and jurisdictions to change their boundaries to include churches that want to affiliate with them. The Renewal and Reform Coalition believes that allowing jurisdictions to set their own standards would lead to a slow-motion splintering of the church and would not resolve the conflict over the church's stance on sexuality and marriage. We oppose parts of the Organic Jurisdictional Solution that would allow that.

#### **TWO JURISDICTION SOLUTION**

These petitions are part of a comprehensive plan to dissolve the current five jurisdictions and put in their place two jurisdictions, a progressive jurisdiction and a traditionalist jurisdiction (or perhaps three jurisdictions, including a moderate jurisdiction). Each could modify the *Discipline* on the issues of same-sex marriage and the ordination of self-avowed practicing homosexuals, with one jurisdiction permitting it and the other strengthening prohibitions against it. Annual Conferences, local churches, and clergy would be free to choose which jurisdiction to belong to. Some evangelicals have been open to this idea as a possible compromise that would keep us together, while other evangelicals have found it unacceptable because it would still allow part of the church to engage in practices that the Bible prohibits—this time with the church's blessing. Most progressives have not been supportive of this proposal because they desire to change the whole church, not just have part of the church to themselves. So the struggle would continue every four years at General Conference—this would not resolve the church's conflict.

This petition would restrict clergy and lay members from submitting petitions to General Conference. It is undemocratic to limit access to General Conference by individuals. This proposal also puts a premium on the institution of the church because all the entities allowed to petition General Conference are institutions of the church. It leaves out the voice of the grassroots.

#### Pet 60226 Page 449 Mandatory Vote

# This petition requires that every petition receiving an affirmative vote by a legislative committee must receive a vote by the plenary session of General Conference. It is unfair to have legislative committees do all their work and then not have it acted upon by the plenary body. In 2012, at least one legislative committee did not get to present any of its petitions to the plenary (other than those on the consent agenda). This requirement would act to deter those who seek to prevent action through delaying tactics and would require better time management of our plenary sessions.

#### **ABORTION**

Abortion is a controversial subject within both our church and society. As Christians, we should lean toward protecting and preserving life whenever possible. Scripture lifts up the personhood of the unborn (e.g., Jeremiah 1:5; Luke 1:44). The early church consistently spoke against abortion and infanticide, which was a common practice among the Romans. While acknowledging that there are

difficult and exceptional cases to consider, we believe United Methodism does best when it advocates on behalf of the lives of unborn children and supports the lives of women in crisis pregnancies. It should not be controversial to compile lists of resources that can help women facing unplanned pregnancies find feasible alternatives to abortion, which is what this petition recommends.

#### **COMMISSION ON THE GENERAL CONFERENCE**

**Discontinue Commission on General Conference** Pet 60528 Page 452 Oppose This petition aims to dismantle the Commission on the General Conference and turn its tasks over to the Connectional Table. However, running the General Conference is not in line with the CT's mission. It is also an overwhelming task in and of itself. Adding it to what the CT already does would be totally unworkable. The coordinating mission of the church would not be attended to, and the running of General Conference would not be done with excellence.

#### CONFERENCING

Pet 61044 Page 404 **Christian Conferencing** 

Oppose This petition adds to the Constitution the mandate that General Conference is to be for the purpose of worship, prayer, and fellowship done in a spirit of Christian conferencing. As classically understood, Christian conferencing is the sharing of one's own faith understandings and experiences with a small group of fellow disciples for the purpose of helping all grow in grace and holiness. This is not the purpose of General Conference. Trying to make General Conference a venue for Christian conferencing distorts the meaning of such conferencing and would lay upon General Conference an unrealistic duty that distracts from GC's true purpose.

#### **CONFLICT OF INTEREST**

Pet 60516 Page 455 Conflict of Interest on Committee on Episcopacy Support This petition aims to eliminate potential conflicts of interest by disqualifying persons in a direct reporting relationship to an active bishop from serving on the jurisdictional committee on episcopacy. This common-sense provision will enhance trust and foster healthier functioning of the committee.

#### **DELEGATE ELECTION**

Pet 60568 Page 435

Elections Support This proposed amendment enshrines one of the principles of election in our Constitution. It protects the right to nominate potential delegates from the floor of annual conference, opening up the process. This provision ensures consistency across the church in how our annual conferences elect delegates to General Conference. It is meant to correct processes followed in some annual conferences that manipulate the process toward hand-picked delegates.

#### EPISCOPAL OVERSIGHT

Pet 60512 Page 414 Authority of General Conference Support This petition changes the Constitution to overturn the Judicial Council decision that ruled Plan UMC unconstitutional at the 2012 General Conference. The petition clarifies that General Conference has the authority to delegate specified and limited authority for oversight without it being a limitation of the general oversight by the bishops.

#### EPISCOPAL SUPPORT

Pet 60068 Page 417 Episcopal Support Support This petition requires that each jurisdiction bear all the financial costs of the bishops serving in that jurisdiction. Financial support for bishops should be a foundational financial obligation. If a jurisdiction cannot support its own bishops, it has too many bishops or needs to develop greater financial capacity. Otherwise, it sets up a situation of long-term financial dependency upon the general church. We would ultimately like to see the central conferences moving in this same direction, as they build their financial capacity, as well. But this petition deals only with the jurisdictions in the U.S. and does not affect the central conferences.

#### **GLOBAL BOOK OF DISCIPLINE**

# Pet 60277 Page 466 General Book of Discipline – Draft No Position

This petition authorizes a churchwide feedback process to help shape a proposed *General Book of Discipline* that would apply equally to all annual conferences and not be subject to adaptation by the central conferences. The new draft would have to take into account all the changes in the *Discipline* made at the 2016 General Conference. The final draft of the *General Discipline* would then be proposed and voted on (with whatever amendments) at the 2020 General Conference. This petition does not commit the General Conference to a final version of the Global Book.

#### JUDICIAL COUNCIL

Pet 60514 Page 415 General Conference Override Judicial Council Declaration Oppose Since the Judicial Council is the primary interpreter of church law, the integrity of the judicial process must be protected. This petition provides that the General Conference could override a Judicial Council decision by a supermajority vote. As frustrating to the body as Judicial Council decisions sometimes are, this move would violate the principle of separation of powers. A better way to overturn unpopular judicial decisions is with legislative action to change the Constitution, which could end up yielding greater clarity in the long run than a simple override.

#### JURISDICTIONAL BOUNDARIES

Pet 60058 Page 436 Flexibility in Number of Jurisdictions Support This petition allows General Conference to change jurisdictional number and boundaries without the need for a constitutional amendment. This provision would give greater flexibility in structuring the church for effective ministry. It would not burden thousands of annual conference members who would have to vote on a boundary change that did not affect them.

Pet 60202 Page 437 Jurisdictional Realignment and Name Change No Position This petition would eliminate the Western Jurisdiction and redistribute its annual conferences among the North Central and South Central Jurisdictions, moving a few other annual conferences to create greater balance. The impetus behind this move, to create more balanced jurisdictions based on membership, is a good one. We have not taken a position on whether this is the best solution.

# Pet 60549 Page 437 Change Jurisdictional Boundaries Oppose This petition would shift four annual conferences into the Western Jurisdiction. Again, the impetus to create more balanced jurisdictions is a good one. However, it would seem that this proposal would create greater imbalance. While helping the Western Jurisdiction, it would decrease the North Central and South Central and create a greater imbalance between those two and the two eastern jurisdictions.

Pet 60941Page 438British Columbia in Western JurisdictionNo PositionThis petition expands the Western Jurisdiction to include British Columbia in order to<br/>incorporate a few congregations located there. We have not taken a position on the wisdom of<br/>this proposal, but think it bears watching.No Position

Pet 60059 Page 465 Jurisdictional Study Committee Support This petition would create a study committee to examine the jurisdictional boundaries and bring a report to the 2020 General Conference. This proposal makes sense as a way to gather more information and allow annual conferences to have input into any recommended change of jurisdictional boundaries.

# LOCAL PASTOR ELIGIBILITY

Pet 60538 Page 435 Local Pastor – Voting Rights and Election to Delegation Support This petition would allow local pastors who have completed educational requirements, provisional, associate, and affiliate clergy members to vote on constitutional amendments and the election of clergy delegates to General Conference, as well as serve as clergy delegates. As local pastors become a larger share of clergy in our denomination, it makes sense that they should serve as delegates, bringing their unique voice and perspective to the General Conference deliberations.

# PLAN OF SEPARATION

In the highly polarized climate of current United Methodism, many believe it is difficult to see how we can continue to live together in one body. Many progressives see the "full inclusion" of GLBTQ persons in the life of the church, including same-sex marriage and ordination, as the civil rights issue of our time. They will not rest until same-sex marriage and the ordination of self-avowed practicing homosexuals are not only allowed but encouraged in the entire church (particularly in the U.S.). At the same time, many traditionalists see this question as a test of biblical authority, which is clearly stated in our doctrinal standards. They would not be able to continue in a denomination that allows or even mandates the performing of same-sex marriage and the ordination of self-avowed practicing homosexuals because they see it as contrary to Scripture. Congregations have been leaving the denomination at an increased pace over the last several years. In light of potentially heightened disobedience or if the position of the church changed, that exodus could grow. Rather than see congregations depart piecemeal, leading to a splintering of the denomination, these petitions provide an organized way of allowing congregations and pastors who could no longer live together to separate with grace and respect. While not universally supported by either progressives or traditionalists, we believe that if separation is to occur, it is better to try to construct new viable denominations out of the separating parties and avoid potential litigation costing millions of dollars. As the Renewal and Reform Coalition, we do not have consensus on these petitions and so are not endorsing them, but simply urging careful, honest consideration of all relevant challenges. We understand that these petitions represent very deep concerns of faithful, valued fellow

United Methodists, and would be more faithful than petitions to authorize same-sex weddings in our church.

Pet 60993 Page 471 **Plan of Separation** Consider This petition lays out a comprehensive process for fairly providing for a separation of the denomination into two or more new entities. By making the annual conference the primary locus of decision-making, it would seek to minimize the impact on local churches that are in agreement with their annual conference position. It would allow an orderly process that would culminate in the organizing of new entities in May 2020, with the appropriate division of assets thereafter. It envisions the entire process being completed by 2022. This petition requires a constitutional amendment, which creates a high bar to passage.

#### Pet 60994 Page 474 Commission on Separation

Consider

This petition would set up a commission to develop a plan of separation that would be presented to a special called session of the General Conference in 2018. It takes the same approach as Petition 60993, but leaves the details to be worked out by the commission, rather than incorporating them into this petition. It would allow greater input from all sectors of the church to consider issues that would need to be resolved in order for the separation to go forward. It has the same goals as Petition 60993: to end the conflict in a fair way without litigation, allowing the church in its new entities to focus on the primary mission of discipleship. This petition requires only a majority vote, which is much easier to obtain than a constitutional amendment.

#### TRANSLATION

Pet 60723 Page 453 Translation of DCA

Support This petition would mandate translation of the daily DCA during General Conference into the official languages of the conference. Without such translation, central conference delegates not fluent in English are at a disadvantage, often not even knowing what is being voted upon or discussed. This is an issue of fairness as we live into the reality of being a global church. Because the document can be distributed electronically, it becomes more possible for timely translation to take place.

Changing the church's position to allow same-sex weddings and/or the ordination of self-avowed practicing homosexuals would separate our church from 2,000 years of the church's consensus teaching and from 95 percent of world Christians today. It would also provoke separation of The United Methodist Church, forcing those who could not in good conscience live with the progressive position to leave the church. We oppose any efforts to remove or weaken the teachings and requirements of our church around marriage and sexuality.

These two petitions aim to revise Resolution 2121 on Teen Suicide related to teen sexual identity. Aside from disliking the term "sexual identity" (our identity is in Christ, not in our sexuality), there is much to like about Petition 60896. It broadens the scope of the resolution to address global needs and issues. Its recommendations are congruent with the current stance of the UM Church on homosexuality. On the other hand, Petition 60894 is narrowly U.S.-centric. It incorporates the term "gender identity," which implies that a person's gender is based on one's own feelings, rather than biological reality, and that gender can be changed (which we disagree with). We much prefer 60896.

#### Pet 60797 Page 582 Resources

This petition instructs the Board of Discipleship "to develop and share on its website a list of books and other recommended resources that clearly affirm our Church's moral standards for

sexual behavior." These resources are needed by clergy and laity in local churches to effectively guide young people in understanding their developing sexuality, as well as to inform adults' moral decisions regarding sexuality. The resources are designed to promote compassionate ministry with same-sex-attracted-persons, teens at risk for suicide and others. This is one of the primary roles of the Board of Discipleship—identifying resources that can help the people in local churches engage in more effective ministry. We would encourage that these resources include some available in other languages, especially the official languages of the UM Church.

#### MARRIAGE

Marriage is the main building block of a healthy family, which then builds a healthy society. It is imperative that the church work to strengthen marriages according to God's design. Christian marriage takes on the added significance of showcasing the image of God through complementary genders (Genesis 2) and symbolizing the union of Christ and the Church (Ephesians 5).

#### Pet 60800 Page 569 **BOD** Responsibilities

This petition requires the Board of Discipleship to prioritize resources that strengthen marriage and families in line with United Methodist teaching about marriage. This needed emphasis will be of great practical help to local churches in their efforts to support and strengthen marriages and families in their congregations and communities.

#### Pet 60782 Page 581 Global Study of Marriage

No Position This petition would form a task force to study marriage. We favor the idea of developing a comprehensive theology of marriage, along with practical recommendations to strengthen the ministry of the church with regard to marriages. However, we would not want to see this study group used to promote a revision in United Methodist teaching on marriage that would advocate same-sex marriage or other forms of marriage contrary to biblical teaching. Therefore, we have not taken a position on this petition. Perhaps it could be amended to mandate that the study would make its recommendations in line with UM teaching and doctrine on marriage.

# **CHARISMATIC MOVEMENT**

Pet 60092 Page 594 **Readopt Resolution** Support This petition readopts Resolution 8015, Guidelines: The United Methodist Church and the Charismatic Movement. This resource helps charismatics and non-charismatics understand each other and work together better in the church. This is a very helpful document.

# CHRYSALIS

Pet 60080 Page 585 **Readopt Resolution** Support This petition readopts Resolution 2101, Support Chrysalis at All Levels of the Church. Chrysalis is a spiritual growth and enrichment program similar to Walk to Emmaus for young people. It has been very effective.

# MORMONISM

Pet 60087 Page 592 Readopt Resolution Support This petition readopts Resolution 3147, Guidelines for Ministering to Mormons Who Seek to Become United Methodists. Changing the church's position to allow same-sex weddings and/or the ordination of selfavowed practicing homosexuals would separate our church from 2,000 years of the church's consensus teaching and from 95 percent of world Christians today. It would also provoke separation of The United Methodist Church, forcing those who could not in good conscience live with the progressive position to leave the church. It is important to maintain clear lines of accountability to what our church has taught for 44 years and continues to require today. We oppose any efforts to remove or weaken our church's standards. Instead, we support efforts to strengthen accountability to our church's standards.

#### Pet 61039 Page 768 Amend Footnote

This petition is necessary because of confusion over what constitutes a "self-avowed practicing homosexual." The General Conference is the only body that can define the term. Currently, persons who are living openly in partnerships or marriages with same-sex spouses are being ordained and appointed as clergy in the UM Church, despite what our *Discipline* says. This is because they refuse to "self-avow" by acknowledging that they are in a sexual relationship with a same-gender partner (the current definition). Broadening the definition to include those who are married to a person of the same sex or gender, as well as those who communicate in a public setting that they are a practicing homosexual, removes ambiguity. It preserves the "public" nature of self-avowal by stipulating that being married or in a domestic partnership (a public act) or making a public statement constitutes "self-avowal." It also would eliminate the need to probe into intimate details of a couple's relationship.

Petition 60781 allows annual conferences to decide to ordain and appoint practicing homosexuals, while Petition 60907 gives that power to jurisdictions or central conferences. All four would allow practicing homosexuals to serve as ordained clergy in at least some parts of The United Methodist Church.

Pet 60799 Page 769 **Qualifications for Ordination** This petition would make clear the current understanding that those engaging in any kind of sexual relationship outside of heterosexual marriage are disqualified from serving as clergy in

#### **MISSION STATEMENT**

It<br/>would help us remember the spiritual dimension of discipleship and the necessity for<br/>evangelism. It is needed to balance the emphasis on world transformation, which too often

becomes the goal, rather than the result, of disciple-making, glossing over the need to "offer them Christ" (Wesley's primary instruction to early American Methodists).

#### **TWO JURISDICTIONS**

This petition is part of a comprehensive plan to dissolve the current five jurisdictions and create two (or three) new jurisdictions covering the entire U.S.—a "progressive" jurisdiction, a "traditionalist" jurisdiction, and possibly a "moderate" jurisdiction. The plan would allow each jurisdiction to set its own standards for ministry, which would allow some jurisdictions to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. This plan would also require annual conferences and local churches to choose which jurisdiction to affiliate with, based on their agreement with that jurisdiction's stance on same-sex marriage and the ordination of practicing homosexuals. Some traditionalists could accept this solution as a compromise, while others could not, but so far there has been no support from the progressive leadership for this approach. This petition must be acted upon along with the rest of the plan. To enact this petition alone would give every jurisdiction the power to adapt the *Discipline* similar to the central conferences and would be a recipe for chaos. At least one, and perhaps three, of the current jurisdictions would allow same-sex marriage and the ordination of practicing homosexuals. It would be well to refer this petition to Committee 3, Conferences, which is dealing with the bulk of the petitions related to this plan.

While on its face this article is irrelevant for the global United Methodist Church, the interpretive paragraph on page 70 of the *Discipline* applies the principles of Article XXIII for countries other than the U.S. It would be better to have replaced Article XXIII with a suitably globally framed paragraph, rather than pursue the blunt instrument of deleting it. There are also questions of procedure, since the *Articles of Religion* are protected by the first restrictive rule (¶ 17).

#### **BIBLICAL AUTHORITY**

Pet 60676 Page 760 Revision of Our Theological Task Support This petition brings much-needed revision to our theological statement, emphasizing the primary authority of Scripture and clarifying how that works out in our theological method. In a time when experience is becoming more important to some in doing theology, it is essential to reinforce the primary authority of Scripture for our life and faith (see *Articles of Religion*, Article V, and *Confession of Faith*, Article IV).

#### **BIBLICAL LANGUAGE**

Pet 60260 Page 778 Readopt Resolution Oppose This resolution discourages the use of masculine terms for God. While acknowledging that the Bible uses a variety of metaphors and descriptions for God, nowhere does the Bible use feminine or neuter terms in addressing God. This resolution goes too far when it discourages the use of biblical language in addressing or describing God.

#### **GLOBAL DISCIPLINE**

- Pet 60276 Page 758 General Book of Discipline No Position This petition accompanies Petition 60277 in Committee 3, Conferences, which authorizes a churchwide feedback process to help shape a proposed *General Book of Discipline* that would apply equally to all annual conferences and not be subject to adaptation by the central conferences. The final draft of the *General Discipline* would then be proposed and voted on (with whatever amendments) at the 2020 General Conference. This petition codifies that process in ¶ 101 of the *Discipline*. We suggest that Part V Social Principles Preface and Preamble be restored (not deleted) as part of the *Discipline* that is not adaptable. These sections contain important theological foundation of the Social Principles. It might be helpful for Petition 60277 to be brought to this committee, so that all petitions on the Global Discipline could be acted on together.
- Pet 60352 Page 758 General Book of Discipline Process Oppose This petition attempts to modify the feedback process being used to shape the Global Discipline, per Petition 60277 in Committee 3, Conferences. Such modifications of the process need to be incorporated into 60277 so that there are not contradictory provisions. The process should not be included in the *Discipline* itself (as this Petition 60352 does), but made part of the non-Disciplinary action of the General Conference, in line with 60277. We further oppose weighting the process unfairly with institutional bodies that would tend to have more influence than the voice of the grassroots of the church. These bodies can certainly be included in the feedback process by the Standing Committee on Central Conference Matters, but should not have official standing, as this petition suggests. Deletion of the first sentence of ¶ 101 loses the description of our Wesleyan way of serving Christ "through doctrine and disciplined Christian life."

# NICENE CREED

Pet 60980Page 759Add Nicene Creed to Doctrinal StandardsSupportThis petition implements the Constitutional amendments in Petitions 60978 and 60979, which<br/>are currently assigned to Committee 7, General Administration. These petitions would add the<br/>Nicene Creed to the Articles of Religion and Confession of Faith as part of our doctrinal<br/>standards. This would more deeply root our standards in the ancient faith of the church, as<br/>articulated by the most widely accepted ecumenical councils. The elements of the Nicene Creed<br/>further define our faith congruently with the Articles and Confession, but go beyond them in

some areas of specificity. The Nicene Creed focuses on the most bedrock articles of Christian faith. Having it as one of our doctrinal standards would reinforce our connection with historic and contemporary world Christianity. It would be helpful if all three petitions could be acted upon by this legislative committee, as requested by the submitters.

#### ABORTION

Abortion is a controversial subject within both our church and society. As Christians, we should lean toward protecting and preserving life whenever possible. Scripture lifts up the personhood of the unborn (e.g., Jeremiah 1:5; Luke 1:44). The early church consistently spoke against abortion and infanticide, which was a common practice among the Romans. While acknowledging that there are difficult and exceptional cases to consider, we believe United Methodism does best when it advocates on behalf of the lives of unborn children and supports the lives of women in crisis pregnancies.

The most urgent need in Africa, Eastern Europe, and the Philippines is for highly trained pastoral leaders who can support the church's ministry and growth. As a denomination, we should structure support for theological education into our regular apportionments, rather than rely upon a once-every-four-years decision about how much we can spare in the budget for this purpose. Having a regular apportionment would ensure a steady funding source upon which theological schools could rely. Petition 60927 establishes central conference theological education as a separate apportioned fund, rather than taking the money from general agencies in the World Service Fund. Petition 60928 establishes how the fund would be administered and sets the amount at \$10 million for the quadrennium. This is a tiny percentage of the \$130 million currently being spent on U.S. theological education.

Removal would thus hurt the worldwide mission and functioning of the general church and annual conference.

This petition clarifies that the responsibility of GCFA extends only to monitoring general church expenditures. Since the security fence was built in Israel, bomb attacks have shrunk to almost zero, saving hundreds of lives each year. For example, Motorola is being boycotted because Israeli soldiers use Motorola cell phones on duty. That is comparable to calling for a boycott of Ford because bank robbers overwhelmingly use Ford trucks in their criminal activity (hypothetical example). Divestment would send a message that our church does not approve of nations acting to defend themselves. While Israel's actions are not above reproach, there needs to be a balanced call for Palestinians to acknowledge Israel's right to exist within secure borders and to renounce violence that often targets innocent civilians, as well.

Currently, only about 10 percent of general board members are from central conferences, even though they make up 40 percent of the church membership. These imbalances unfairly privilege certain regions of the church while diminishing the voice of others. While we acknowledge that different forms of sexual attraction exist, we do not agree that all forms of sexual attraction are equally commendable. The church should not commit itself to including persons in leadership (the implications of the last sentence in Article IV) who define themselves by and actively pursue attractions that are contrary to Scripture. In the same way, we oppose the use of a category called "gender identity" as a basis for inclusion. #### **CHARGEABLE OFFENSES**

These petitions deal with various chargeable offenses that are proposed to be added.

#### Pet 60070 Page 1017 Chargeable Offense

Those who disagree with our church's standards and teaching regarding sexuality and marriage have taken to "ecclesiastical disobedience," including disrupting meetings and imposing their agenda on bodies of the church. Such behavior is not in keeping with Christian conferencing and indeed is a form of bullying. As such, it should not be allowed in the church. Church bodies should not be held hostage by a vocal minority of demonstrators, nor should the body's ability to do what the church tasks it to do be prevented (often at great expense of the time wasted). The proposed petition needs to be amended to add the phrase "by conduct that violates that body's rules." The full chargeable offense would then read, "interfering with the General Conference or another United Methodist body or agency's ability to conduct business by conduct that violates that body's rules."

#### Pet 60890 Page 1021 Chargeable Offenses

This petition proposes adding as a chargeable offense "waging war." While most Christians would agree that war is heinous and not in keeping with God's ultimate will, most Christians would also agree that in a fallen world, war is a necessary evil of last resort in order to protect innocent people from the aggression of others. Romans 13:1-5 states that God gives the one in authority the right to "bear the sword" as "God's servant, an agent of wrath to bring punishment on the wrongdoer." John the Baptist did not command soldiers to abandon their occupation (Luke 3:14), and the first Gentile convert was a commanding officer in the Roman army (Acts 10).

## Pet 60593 Page 1021 Chargeable Offense

This petition would add "believer's baptism" as a chargeable offense. The phrase is vague and undefined. While our doctrinal standards encourage infant baptism, they do not deny baptism to youth or adults who come to Christ later in life and have not been baptized. Such baptism could be a chargeable offense under this petition. Furthermore, our doctrinal standards do not forbid infant dedication, should the parents so desire.

#### **COUNSEL FOR THE CHURCH**

The process of church discipline and accountability are essential for a functioning denomination. To maintain the integrity of the process, the counsel for the church must agree with the provision of the *Discipline* he/she is asked to uphold through the accountability process. Having a church counsel who publicly has opposed the disciplinary provision they are tasked to uphold erodes trust and creates the appearance of impropriety. Petition 60595 seems the best way to accomplish this, although other options could be considered. Some of the language from 60594 could be incorporated in 60595.

#### **EPISCOPAL ACCOUNTABILITY**

It is currently nearly impossible for bishops to be held accountable for maintaining their conduct within the requirements of the *Discipline*. No bishop has ever been brought up on charges through the committee on investigation since the church was founded in 1968, despite the filing of substantive complaints. One major reason is that a bishop's colleagues and friends are the ones tasked with holding the bishop accountable. The Council of Bishops sees itself as powerless to foster accountability. Regional differences in the church mean that different standards are used for bishops in different parts of the U.S. and the world. A variety of proposals have been submitted to rectify this situation and enable greater accountability.

The three sets of petitions above represent two different proposals to revise the complaint process for bishops. Petition 60029 comes from the Kentucky Conference, the second group is similar, submitted from Reynoldsburg, OH. The third group of petitions is a slightly different approach submitted by the Western Pennsylvania Conference. We suggest the committee take the best of all the proposals and combine them into one. Important principles for reforming the episcopal complaint process include: 1) placing the disposition and handling of complaints out of the hands of fellow bishops as much as possible, 2) ensuring that a representative group of laity and clergy will deal with complaints against bishops, 3) ensuring that bishops will be held accountable to a global body, rather than a body made up only from their jurisdiction or central conference, and 4) ensuring that complaints are dealt with in a timely manner without the possibility of lengthy delays.

#### **GLOBAL STRUCTURE**

These two petitions are similar amendments to the constitution that are part of a comprehensive plan to restructure the church at the global level. The ultimate aim of this plan is to create the U.S. as its own central conference that is able to adapt the *Book of Discipline* to the unique needs of our cultural situation. In reality, it is an attempt to structure the church in a way that lessens the voices of African, European, and Filipino delegates in denominational affairs and would ultimately allow the U.S. part of the church to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. It is ironic that for many years the U.S. has had a determinative voice in how the central conferences operated, but now that the central conferences are able to have a strong voice in U.S. affairs, that voice is being rejected. The Renewal and Reform Coalition opposes this attempt to restructure the church in an effort to resolve our theological differences.

This resolution would ask United Methodists to ignore the standards we have set as a church for how we expect our clergy to behave. Such an approach undermines the connection that binds us together, makes our General Conference decisions meaningless, and creates a precedent for ignoring other parts of the *Discipline* with which individuals disagree.

#### JUST RESOLUTION

Just resolution is an honorable attempt to resolve possible violations of the *Discipline* in a more amicable way that avoids the need for a trial. Recently, however, the just resolution process has been used to circumvent the requirements of the *Discipline* and in effect condone violations of its requirements. These petitions aim to restore integrity to the just resolution process.

#### Pet 60027 Paae 1010 Complainant as Party to Just Resolution

This petition requires that the complainant have a say in whether the complaint is considered "resolved" through a just resolution. Reconciliation (the aim of a just resolution) cannot take place without the participation and agreement of the complainant. It is important to note that the complainant's refusal to accept a just resolution does not automatically lead the complaint to trial. It would still have to pass the committee on investigation before a trial could be held, and that body could dismiss the complaint without trial.

#### Pet 60028 Page 1011 Definition of Just Resolution

This petition defines a just resolution as one where the respondent apologizes for acknowledged violations of the Discipline and commits not to repeat the offense. Without these elements, a just resolution is not "just," nor does it truly resolve the complaint. It *de facto* condones the violation. Without these elements, there is no expression of repentance, so there can be no effective restoration of the respondent to the church body.

The issue of penalties in trials needs clarification from several aspects. In addition, recent and growing instances of disobedience to the church's prohibition on performing same-sex weddings threaten to make this prohibition meaningless. In very few cases has a meaningful consequence been levied against a person found to have committed the offense. Consequences have ranged from a 24-hour suspension to writing a paper to no consequences at all. A specific penalty is needed regarding this offense because it is the only offense for which a nationally orchestrated campaign of disobedience is being pursued. Since this is a global requirement, there should be a consistent understanding of the penalty, which removes ambiguity and prevents the tacit condoning of violations of the Discipline by levying no meaningful consequence. The first petition represents the best alternative of a clear and consistent penalty for this offense.

Since the Judicial Council is the primary interpreter of church law, it is essential that the church be able to operate under an authoritative interpretation. These two petitions allow greater access to bring questions of church law interpretation and implementation to the Judicial Council. Petition 60527 allows the annual conference, the basic unit of the church, to request such interpretations. Petition 60521 allows the annual conference lay leaders, as the primary representative body of laity, to request such interpretations.

#### **ORGANIC JURISDICTIONAL SOLUTION**

This petition is part of a comprehensive plan to allow each jurisdiction to set its own standards for ministry, which would allow some jurisdictions to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. #### **CHURCH PROPERTY**

In the current climate of polarization within The United Methodist Church, questions have been raised about the possibility of separation. Local churches on both sides of the question of homosexuality and marriage have voted to leave the denomination. This has been handled by each annual conference on a case by case basis, leading to inconsistency in how these situations are treated. These two petitions propose ways of standardizing the handling of churches desiring to leave the denomination. We believe that covenant cannot be coerced, and that churches that are unwilling to live within the boundaries of our covenant ought to have the freedom to leave the denomination with their property without undue penalty. Many laypersons believe it is unfair that the denomination should be able to keep the church's property in that case, since it is the local members who built it and provide the upkeep. Allowing frustrated churches who are unwilling to continue supporting our denominational covenant to exit may relieve the pressure of conflict and allow the denomination to refocus its energy on its mission.

#### Pet 60811 Page 1043 Disaffiliation

This petition provides a process of exit for congregations who are "in irreconcilable conflict for reasons of conscience with the provisions of The Book of Discipline ... on the practice of homosexuality and the blessing of homosexual unions." It is thus limited only to churches who cannot accept United Methodist teaching and requirements around these issues. Such congregations are now increasingly engaged in disobedience to the *Discipline* because of their conscientious position. Exit would require a period of study and discernment, a two-thirds vote of the church conference, and the local church assuming all debts. The local church could then keep its property. We would be open to adding to this petition the additional requirements that Petition 60812 would impose on departing congregations.

#### Pet 60812 Page 1044 Disaffiliation

This petition is similar to the first, except that the reason for leaving is a bit broader. In light of the "deep conflict over the church's position on the practice of homosexuality and the blessing of homosexual unions," a church could leave if "for reasons of conscience, witness, or mission it can better serve Christ and his kingdom by not being affiliated with The United Methodist Church." This petition would allow churches who feel strongly on either side of the question to depart, if they felt they could not longer conscientiously serve within United Methodism. In addition to the requirements imposed by the first petition, this petition also requires the local church to repay to the annual conference money invested by the conference in the local church during the previous five years and to pay one additional year's apportionment in full.

#### HOMOSEXUALITY

The church's balanced, compassionate, and biblically faithful position on the practice of homosexuality has been reaffirmed by ten General Conferences over 40 years. Despite vociferous disagreement by some parts of the church, it still represents the majority opinion of the grass roots church membership

worldwide. Changing the church's position to allow same-sex weddings and/or the ordination of selfavowed practicing homosexuals would separate our church from 2,000 years of the church's consensus teaching and from 95 percent of world Christians today. It would also provoke separation of The United Methodist Church, forcing those who could not in good conscience live with the progressive position to leave the church. We oppose any efforts to remove or weaken the teachings and requirements of our church around marriage and sexuality.

#### Pet 60839 Page 1041 Responsibilities of S/PPRC

This petition mandates a non-discrimination policy for lay staff based on "age, race, gender, gender identity, sexual orientation, or marital status." Such broad language could mandate that churches hire practicing homosexuals, transgender persons, and unmarried cohabiting heterosexual persons as lay staff. It would open the local church to increased legal liability to being sued over employment decisions. Congregations could be forced to hire and promote people who do not ascribe to the congregation's values. Including "gender identity" as a category is an implicit affirmation that a person's gender is based on one's own feelings, rather than biological reality, and that gender can be changed. Our statement on inclusiveness is already found in ¶ 4 of the constitution and in ¶ 140, so there is no need to reiterate it here in a way that opens up legal liability for the congregation.

#### WOMEN'S MINISTRY

The importance of various forms of women's ministry in the local church is unquestioned. Unfortunately, the *Discipline's* support for United Methodist Women as the primary ministry for women has led pastors, superintendents, and bishops in some areas to oppose or even prohibit any other form of women's ministry. These two petitions emphasize the importance of women's ministry and open the door to a variety of formats in addition to UMW being able to function well in the local church.

### Pet 60614 Page 1038 Supplemental Ministries

This petition encourages supplemental ministry programs for women and men in addition to United Methodist Women and United Methodist Men.

### Pet 60844 Page 1050 Women's Ministry

This resolution lifts up the importance of women's ministry in the local church and encourages local churches to provide supplemental women's ministry programs that fit the unique needs of women in each church.

#### **LEADERSHIP STANDARDS**

It is important that local church leaders affirm the teachings of our denomination, so that the ministry and mission of the local church can be unified around a common foundation of essential matters. Since we require local church leaders to be "loyal to the ethical standards ... in the Social Principles," we should also require leaders to affirm our doctrinal teachings, as well.

#### **ORGANIC JURISDICTIONAL SOLUTION**

This petition is part of a set of petitions being handled by Committee 3, Conferences, and we recommend that it be referred there to be dealt with together. This is a comprehensive plan to allow each jurisdiction to set its own standards for ministry, which would allow some jurisdictions to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. This plan would also allow local churches to affiliate with a different annual conference, annual conferences to affiliate with a different jurisdiction, and jurisdictions to change their boundaries to include churches that want to affiliate with them. The Renewal and Reform Coalition believes that allowing jurisdictions to set their own standards would lead to a slow-motion splintering of the church and would not resolve the conflict over the church's stance on sexuality and marriage. #### **BISHOPS**

These petitions deal with various aspects of the ministry of the episcopacy.

It is currently nearly impossible for bishops to be held accountable for maintaining their conduct within the requirements of the *Discipline*. No bishop has ever been brought up on charges through the committee on investigation since the church was founded in 1968, despite the filing of substantive complaints. One major reason is that a bishop's colleagues and friends are the ones tasked with holding the bishop accountable. The Council of Bishops sees itself as powerless to foster accountability. Regional differences in the church mean that different standards are used for bishops in different parts of the U.S. and the world. A variety of proposals have been submitted to rectify this situation and enable greater accountability. This lack of accountability breeds cynicism and a sense of unfairness in our judicial system.

### **CLERGY DOCTRINAL STANDARDS**

While The United Methodist Church has clear doctrinal standards enumerated in ¶ 104 of the *Discipline*, it is not always clear that our clergy maintain their preaching and teaching within the boundaries set by these standards. Current questions for examination do not address a candidate's personal beliefs, only their knowledge about the church's teachings. These three petitions in different ways require that clergy candidates for ordination must affirm the content of our doctrinal standards as their own belief prior to being approved for ordination. Some combination of Petitions 60632 and 60650 would seem to be the most practical way of ensuring that the preaching and teaching of our clergy upholds the message contained in our doctrinal standards.

### **CLERGY PENSION**

Having this reassurance would enable clergy who no longer feel called to ministry, who are ineffective, or who by reason of conscience can no longer support the teachings and requirements of the denomination to more readily withdraw.

### **COMPLAINTS**

The filing of complaints is one way to hold bishops, clergy, and laity accountable to strive for holiness of life. When complaints are not seriously addressed or are prematurely dismissed, the integrity of this accountability process is jeopardized. This petition aims to restore integrity to the complaint process by forbidding a bishop from dismissing a complaint where there is credible evidence that a violation of the *Discipline* has occurred. #### **GLOBAL STRUCTURE**

These two petitions are similar amendments to the constitution that are part of a comprehensive plan to restructure the church at the global level. The ultimate aim of this plan is to create the U.S. as its own central conference that is able to adapt the *Book of Discipline* to the unique needs of our cultural situation. In reality, it is an attempt to structure the church in a way that diminishes the voices of African, European, and Filipino delegates in U.S. denominational affairs and would ultimately allow the U.S. part of the church to permit same-sex weddings and the ordination of self-avowed practicing homosexuals. In return, they deserve protection from arbitrary and potentially punitive episcopal decisions. This is a sledgehammer approach to dealing with ineffective clergy. We already have a fair and equitable way to address clergy ineffectiveness that also protects clergy rights to fair process. This step is not needed.

#### HUMAN SEXUALITY

The church's balanced, compassionate, and biblically faithful position on the practice of homosexuality has been reaffirmed by ten General Conferences over 40 years. Despite vociferous disagreement by some parts of the church, it still represents the majority opinion of the grass roots church membership worldwide. Changing the church's position to allow same-sex weddings and/or the ordination of self-avowed practicing homosexuals would separate our church from 2,000 years of the church's consensus teaching and from 95 percent of world Christians today. It would also provoke separation of The United Methodist Church, forcing those who could not in good conscience live with the progressive position to leave the church. We oppose any efforts to remove or weaken the teachings and requirements of our church around marriage and sexuality.

#### TERM LIMITS FOR BISHOPS

The inconsistency of episcopal terms in different parts of the worldwide denomination sets up a situation of inequality among bishops between those with life tenure and those required to be reelected. Setting a common term for all bishops creates a more level power situation. Providing for a limited (rather than lifetime) term allows for the best episcopal leadership for any particular place at a certain time, rather than thinking that the qualities possessed by a bishop can serve all leadership needs for 16-20 years. We view the essential points as 1) providing the same term for all bishops worldwide, and 2) providing for a limited term, rather than a lifetime term. There is disagreement as to the advisability of having bishops stand for reelection, so we will lean upon the wisdom of the body for that aspect of the question.

The Social Principles should be broad enough "principles"<br/>that they would cover every cultural situation. If not, they are too specific. The Social Principles<br/>should hold true for the entire denomination (that is why they are in the Book of Discipline,<br/>rather than the Book of Resolutions).

#### **AFRICA BISHOPS**

The central conferences of Africa need more bishops in order to equalize the burden of the number of members per bishop, along with the distance of travel within some countries. The Standing Committee has proposed postponing the addition of more bishops until 2020. Since additional bishops were first proposed in 2008, this would be a 12-year wait, in which time the urgent need for bishops will get only greater. We believe some bishops can be added now, and the SCCCM can still pursue its study to determine what additional areas need more bishops. It is evident that there is an urgent need for at least two bishops now, one in the Congo Central Conference and one in Nigeria.

It is currently nearly impossible for bishops to be held accountable for maintaining their conduct within the requirements of the *Discipline*. No bishop has ever been brought up on charges through the committee on investigation since the church was founded in 1968, despite the filing of substantive complaints. One major reason is that a bishop's colleagues and friends are the ones tasked with holding the bishop accountable. The Council of Bishops sees itself as powerless to foster accountability. Regional differences in the church mean that different standards are used for bishops in different parts of the U.S. and the world. A variety of proposals have been submitted to rectify this situation and enable greater accountability. Legislative Committee 10, Judicial Administration, is handling the bulk of these petitions. Petition 60918 should be referred to LC 10, so that all the petitions related to the proposals found in Legislative Committee 10.

#### FAIR REPRESENTATION

As the membership makeup of the denomination changes, it is important that different regions are fairly represented on the general boards and agencies. Imbalances among the jurisdictions and central conferences unfairly privilege certain regions of the church while diminishing the voice of others. We support proportional representation on the Standing Committee, while maintaining minimum assured representation from all areas of the church. We would ultimately like to see the Standing Committee composed of more central conference members than U.S. members.

These two petitions adjust the membership of the Standing Committee. The two are complementary and should be combined. The number of members should be proportional to the membership of each jurisdiction and central conference as proposed by Petition 60555. We agree that members of the Standing Committee should be elected by the jurisdictional and central conferences, rather than named by the bishops, a change proposed by Petition 60273. The language on the number of members from central conferences in 60273 is unclear and should be clarified and made more specific. The Standing Committee should consider both proposals and work to ensure proportional membership among the jurisdictions and the central conferences, along with the election of members.
